ENTREPRENEURSHIP, TRADE AND COMMERCE

Entrepreneurship, trade, and commerce are at the heart of Uganda's economy. Small businesses, farmers' cooperatives, cross-border traders, and large enterprises all play a vital role in providing jobs, income, and goods. Governance determines whether these activities

thrive in an environment of fairness and opportunity — or struggle under corruption, weak infrastructure, and poor policy.

1. Entrepreneurship in Uganda: The Spirit of Innovation

- Uganda has one of the highest rates of entrepreneurship in Africa, especially among youth and women.
- From agriculture processing to ICT startups, Ugandans demonstrate resilience and creativity.

Governance Impact: Entrepreneurs need access to credit, supportive policies, training, and protection from exploitation.

2. Trade and Commerce as Lifelines of the Economy

- Uganda's domestic trade fuels local economies, while regional and global trade expand markets.
- Exports: coffee, fish, gold, tea, maize, flowers.
- Imports: fuel, machinery, textiles, electronics.
- **Governance Impact:** Trade thrives when there is infrastructure, fair taxation, and strong cross-border agreements. Poor governance creates barriers like excessive bureaucracy, bribery, and poor roads.

3. The Role of Governance in Commerce

- Policy: Sound trade policies (tariffs, export promotion, customs) shape competitiveness.
- Infrastructure: Roads, rail, ports, and digital systems determine trade efficiency.
- **Regulation:** Laws protect consumers, ensure fair competition, and create predictability.
- **Anti-Corruption:** Governance must eliminate bribery at borders, markets, and licensing offices.

4. Barriers and Failures in Governance

- High cost of credit for small businesses.
- Corruption and bribes at customs and licensing offices.
- Informal traders harassed by authorities.
- Weak policies on value addition: Uganda exports raw coffee, tea, and gold instead of finished products.
- Trade disruptions due to political instability or poor cross-border cooperation.

5. Opportunities for Transformation

- Value Addition: Processing coffee, cotton, and other exports locally.
- **Regional Trade:** Tapping into the East African Community and African Continental Free Trade Area (AfCFTA).
- **Digital Commerce:** E-commerce platforms expanding access to markets.
- Youth Entrepreneurship: Training, incubation hubs, and startup financing.
- **Fair Policies:** Governance that supports SMEs, protects traders, and ensures just taxation.

UGANDA'S COFFEE TRADE AND THE CHALLENGE OF VALUE ADDITION

Uganda is currently Africa's largest exporter of coffee, a position it secured in May 2025 by surpassing Ethiopia in export volume. Uganda achieved this milestone with a significant



increase in exports, demonstrating strong growth in its coffee sector and a strategic focus on quality standards, farmer support, and government investment.

Coffee is the country's leading export earner, contributing over \$850 million annually and supporting the livelihoods of 1.8 million households. Coffee is often called "Uganda's black gold."

Uganda has become the world's largest exporter of Robusta. Yet, while Uganda grows some of the finest Robusta and Arabica beans, most coffee is exported in raw form, with very little local processing. This means the bulk of profits go to foreign roasters and exporters, while Ugandan farmers remain poor.

The Governance Challenge

- 1. Lack of Value Addition: Less than 10% of Uganda's coffee is processed locally into instant or roasted coffee.
- 2. **Weak Policies:** Past attempts at enforcing value addition (e.g., the controversial Vinci Coffee Agreement) sparked debates on transparency, fairness, and governance.
- 3. **Market Barriers:** Export taxes, high electricity costs, and weak infrastructure make it harder for local processors to compete globally.
- 4. **Farmer Income:** Farmers often sell unprocessed coffee cheaply, while international markets reap large profits.

Proverbs 13:23 — "The field of the poor may produce much food, but it is swept away through injustice."

Opportunities for Uganda

- **Local Processing:** Building roasting and instant coffee factories to capture more export value.
- **Entrepreneurship:** Supporting small and medium enterprises (SMEs) in coffee branding and specialty markets.
- **Global Trade Agreements:** Leveraging the African Continental Free Trade Area (AfCFTA) to expand African coffee markets.
- Fair Trade Certification: Promoting ethically sourced Ugandan coffee to premium international buyers.

Ecclesiastes 3:13 — "That each of them may eat and drink, and find satisfaction in all their toil—this is the gift of God."

Lessons for Governance

- Good governance must balance regulation and freedom: encouraging investment while ensuring transparency.
- Policies should empower farmers and entrepreneurs, not just multinational corporations.
- Infrastructure (roads, electricity, internet) and affordable financing are essential for value addition.

When aligned with righteousness, governance allows commerce to become a vehicle of prosperity and justice.
